





**Year Constructed or Established: 1993** 

**Recreational Opportunities:** Fishing (including national bass tournaments), boating, and camping







**Annual Visitation:** 15,000 at 70 boat-in campsites

District or Unit Name: Colorado River District

#### WATER AND UTILITIES PROJECT

**Purpose and Need:** The existing dock and ramp have reached the end of their useful life and require replacement due to rotting wood that poses a safety risk to users. This project will provide a safe and low-maintenance launch area by replacing the old wooden dock with an aluminum dock. This replacement will meet ADA requirements to improve accessibility and visitors' experiences launching boats at Lake Havasu.



## **Burro Creek Recreation Site Water System and Dump Station Repair**

**ARIZONA** Project ID L008





District or Unit Name: Colorado River District

Year Constructed or Established: 1970 (upgraded in 1990)

Recreational Opportunities: Tent camping, RV camping, and group camping with amenities (fire grill, trash can, picnic table, sun-shelter ramada, parking space, potable water, restrooms with flush toilets and sinks, and an RV dump station)







**Annual Visitation:** 19,742 individual visitors and 664,157 visitor days in 2019

#### WATER AND UTILITIES PROJECT

**Purpose and Need:** The existing water system violates safety standards and poses a health risk to the visiting public. Complete renovation of the potable water system at the Burro Creek Recreation Site is necessary to eliminate the water system violations and provide safe drinking water for the recreating public.





## **Haekel Road Rehabilitation Chip Seal** (Phase 1 of 2)

**ARIZONA** Project ID L009





**District or Unit Name:** Gila District

Year Constructed or Established: 1970 (paved in 2006)

**Recreational Opportunities:** Off-highway vehicle use (Hot Well Dunes), hunting, camping, wildlife viewing, and other dispersed recreational opportunities











**Annual Visitation:** 10,000 at Hot Well Dunes Recreation Area; 4,170 vehicles on road monthly

#### TRANSPORTATION PROJECT

**Purpose and Need:** Haekel Road is a degrading asphalt road with potholes, rutting, and spalling, all of which pose a serious safety risk. Accidents have occurred on this road that resulted in serious injury. This project will repair the road surface and subgrade to resolve road safety issues and provide safe access to Hot Well Dunes Recreation Area, which attracts thousands of OHV enthusiasts every year.
