Required analysis for categorically excluded activities is generally completed within a one to four-week time frame. This frequently occurs in between publications of the *Planning Update*. #### **Coos Bay District Invasive Plant Management EA**

DOI-BLM-ORWA-C000-2017-0003-EA

**Description:** The action is to utilize additional herbicides to treat noxious and invasive weeds species. Additional site-specific EAs will be completed for limited application for general vegetation control around facilities and for habitat improvement. The action does not include aerial application of herbicides or herbicide use for timber or livestock production.

In 2007, the BLM completed the Vegetation Treatments Using Herbicides on Bureau of Land Management Lands in 17 Western States Programmatic Environmental Impact Statement (EIS) and related Record of Decision, making 18 herbicides available for a full range of vegetation treatments in 17 western states, including Oregon. The BLM completed a statewide EIS and Record of Decision in 2010, *Vegetation Treatments Using Herbicides on BLM Lands in Oregon*. This EA tiers to those broader-scale environmental impact statements.

#### Chetco Bar Fire Emergency Stabilization and Rehabilitation CX

**Description:** The Myrtlewood Field Office is proposing emergency stabilization and rehabilitation actions in areas affected by the Chetco Bar Fire. The fire burned on steep slopes and drainages across four watersheds totaling 185,920 acres of which 6,501 are administered by the Bureau of Land Management (BLM). A Burned Area Emergency Response (BAER) team was assigned, and have created a Fire Recovery Plan assessing the potential stabilization, rehabilitation, and restoration actions needed to help protect human life and property on these BLM managed lands.

#### **Definitions and Abbreviations**

**Area of Critical Environmental Concern (ACEC)** – Lands where special management attention is needed to protect and prevent irreparable damage to important historic, cultural, or scenic values, fish, and wildlife resources or other natural systems or processes or to protect life and provide safety from natural hazards.

**Categorical Exclusion (CX)** – Actions which do not have significant effects on the environment and for which an Environmental Analysis (EA) or an Environmental Impact Statement (EIS) is not required.

Commercial thinning (CT) – Stand thinning in which some or all of the cut trees are removed from the stand for timber. 'Commercial thinning' in this context does not include individual tree falling or stand thinning in which all the cut trees are left in the stand or some of the cut trees are moved for restoration purposes, or fuels reduction treatments in which cut trees are burned, chipped, or otherwise disposed of without removal from the stand for timber. 'Commercial thinning' may be implemented through a variety of mechanisms, including timber sale contracts and stewardship agreements or contracts.

**Determination of NEPA Adequacy (DNA)** – Documentation of BLM's internal analysis process that a proposed action conforms to its land use plan and is adequately analyzed in an existing NEPA document.

**Environmental Assessment (EA)** – This is a concise public document that briefly provides evidence and analysis of a proposed Federal action. It is used to determine whether further analysis needs to be done for an Environmental Impact Statement (EIS) or a Finding of No Significant Impact (FONSI).

**Finding of No Significant Impact (FONSI)** - This is a document that briefly presents the reasons why the implementation of an action will not result in "significant" environmental impacts (effects) beyond those already addressed in the *Final Coos Bay District Proposed Resource Management Plan/Environmental Impact Statement* (USDI 1994) or the *Final Proposed Resource Management Plan/Final Environmental Impact Statement for the RMPs for Western Oregon (USDI 2017)*.

**Land Use Allocation** – The identification in a land use plan of the activities and foreseeable development that are allowed, restricted, or excluded for all or part of the planning area, based on desired future conditions.

**National Environmental Policy Act (NEPA)** – A federal law which sets the systematic interdisciplinary analysis to achieve integrated consideration of physical, biological, economic, and other sciences to provide for an informed decision. The process provides for public participation in the development, review and revision of certain activities on Federal Lands.

**Public Involvement/Scoping** - An early and open part of environmental analysis that allows interested public and other Federal, state and local agencies the opportunity to provide issues, concerns and opportunities relative to proposed project actions. Scoping is required by regulation for Environmental Impact Statements and is optional for Environmental Assessments.

**Regeneration harvest(ing)** – Any removal of trees intended to assist regeneration already present or make regeneration possible.

**Resource Management Plan (RMP)** – A land use plan as prescribed by the Federal Land Policy and Management Act that establishes, for a given area of land, land-use allocations, management objectives, and management direction.

**Right-of-way** (**R**/**W**) – A permit or an easement that authorizes the use of public lands for specified purposes, such as pipelines, roads, telephone lines, electric lines, reservoirs, and the lands covered by such an easement or permit.

**Salvage harvest(ing)** – Removal of dead trees or of trees damaged or dying because of injurious agents other than competition, to recover their economic value.
