Overview of Field Trip

- Purpose of revisiting: Give the Council members time to provide comments or feedback post overnight reflection.

- Field trip stops and discussions:
 - Buckhorn Draw- Special Recreation Permit (SRP)s being supported at a general level.
 - Calf Canyon- wilderness and access, camping/ climbing
 - I-70 Interpretive Signs- Good public feed back on signage was received.
 - Temple Mountain- Camping and success of parking improvements
- Questions
 - Is there not blanket BLM management for special recreation rules?
 - There are certain management activities that are blanket and some that are site specific.
 - Can the BLM work with other agencies at peak times to improve law enforcement efforts?
 - There was discussion around this question with general agreement that it may be a good idea.
 - Can BLM work with Emery County for enforcement?
 - BLM has a contract with the Sheriff's office for this purpose.
- General Notes
 - Council support of signage and history conveyed and Temple Mountain improvements.
 - Respect conveyed for understanding the gravity of the BLM's task.
 - Council wants- more signage, information on wildlife and plant habitats.
 - Council concerns with Travel Management Plan (TMP) because the Dingell Act says no new roads can be built in the Recreation Area and population growth is expected in the future.
 - BLM requested feedback from the council about where dispersed camping will be allowed and how new dispersed camping will be defined
 - SRSRAAC general concerns- social and resource carrying capacities, parking/ camping at corrals.

Public Comment Process

Designated Federal Officer, Green River District Manager Elijah Waters (Acting)

- The public is addressing the Council not the BLM. During this time, the council is looking for specific, constructive comments that are backed by data.

Public Comment Period

- Patrick McKay: TMP concerns
 - Maps do not show inventory closed routes though they would like to see all routes.
 - Maps do not distinguish County B and D roads.
 - Paved roads, specifically 100 miles of Interstate-70, are included in the analysis creating an artificial inflation of inventories.
- Michael Fredricks wants the Council to make a recommendation for climbing to be a historical use and implement rules for replacement of old climbing anchors.
- Jim Jennings clarified that the Victor Johnson (VJ) Trail was discussed earlier in the interactive map portion of the day.
- Larry Ellertson read Congressional letter records from Senator Romney and Congressman Curtis.
 - Never take away any use from existing use.
 - Clerical errors should be resolved.
 - Preservation of cherry stemmed roads.
 - Prevention of designation of National Monument status.
- Judy Brower would like for the discussions of wildlife mentioned in the Overview of the Field Trip section to come to fruition. They also notified the Council that they would be lodging a complaint with the Department of the Interior for interactions with the Council that occurred on March 6, 2024.
- Clay Crozier hopes that the Council will follow the intention of Congress. The State will be supporting Travel Management Plan Alternative D. They encourage the Council to evaluate rationale for removal of duplicative routes.

 - Honor the future court decisions regarding RS-2477 routes.
 - Develop a well balanced TMP that opens more miles of routes but closes routes with resource issues.

 - Can a BLM solicitor further research the intent within the Dingell Act?





These will help BLM understand current conditions and trends of the resources and the uses/activities that will relate to potential decisions in the plan amendment.










Buckhorn, The Wedge, Mexican Mountain Recreation Management Zone



Potential Alternative

- Are ROS classes necessary? Are they in the appropriate areas? Should they be re-evaluated?
- Should BLM change anything at all?



Other Possible Alternatives

- Determine if dispersed camping should continue, and where it should be allowed. Is a permit necessary?
- Determine proper limitations on fuelwood collection, requirements for campers (fire pans, portable toilets).
- Areas where recreation development is appropriate and where it should be avoided.
- Determine where to issue Special Recreation Permits and what type of permits.
- Evaluate Visual Resource Management classes.
- Remove, retain, or modify ACECs.
- Determine appropriate areas for right-of-ways and what types.

Background Information and 2024 Schedule



Purpose & Need


The purpose of this travel planning project is to designate inventoried and evaluated routes within the Travel Management Area (TMA) as open, limited, or closed to public Off Highway Vehicle (OHV) use, and to adopt a TMP Implementation Plan, thus creating an OHV travel network that provides clarity for users, reduces user conflicts, protects both natural and cultural resources, meets access needs, increases public safety, and addresses enforceability issues.

ROUTE DESIGNATIONS DEFINED

Open: A route that is recommended open for all modes of travel and uses.

Limited: A route that is recommended for limited use by travel mode, user, or season of use.

Closed: A route that is recommended for closure to OHV use, though authorized uses may continue. An OHV closed route may be reclaimed, barriers may be installed, and signs may be placed.



the term “public OHV” includes passenger vehicles in addition to traditional OHV’s such as 4WD, side by sides, and motorcycles.

The need for the project is driven by the Bureau of Land Management (BLM's) obligation to comply with the 2017 Settlement Agreement and the decisions and objectives reflected in the 2008 Resource Management Plans (RMPs).




Zoomed in on Price Field Office Boundary




- 1.15m acre Travel Management Area

WHAT?

This Travel Plan will not result in any new roads, only existing roads and trails have been inventoried. This Travel Plan will only make OHV decisions on BLM managed lands within the project planning area. No motorized routes will be considered within Wilderness Areas.



WHAT?


The BLM is reviewing 2,159 miles of existing routes in the San Rafael Swell Travel Management Area. The Travel Management Area encompasses portions within the Price and Richfield Field Offices.

Each route has been reviewed by an interdisciplinary and inter-agency team of specialists, who have identified a purpose and need for the route and resources that are on or near each evaluated route.





Background Info



- 2003 Travel Plan
- 2008 RMP
 - Adopted 2003 Travel Plan
 - Changed area designations
 - Made additional route designations
- 2008 RMP was challenged and lead to a court settlement in 2017.
- Settlement outlined this TMA boundary
- Required Cultural Inventories in ACECs and Areas of High Potential.
- Required BLM to do Baseline Monitoring in LWC units, Natural Areas, and WSA Areas.
- 2019 Dingell Act Designations: 14 Wilderness Areas, 1 Recreation Area, and 1 National Monument was designated. There were also several Land Conveyances and Exchanges.



Past Schedule Highlights

- Route Inventories: 2014-present,
- Initial Route Evaluations: 2019-2020
- Public Scoping: February 2021
- Endangered Species and Cultural Resource Inventories: 2021-2022
- Completed Wilderness Character Baseline Monitoring Reports: 2023
- Updating Route Evaluations and Alternatives: October 2023 - February 2024

- Scoping comments, network connectivity, purpose/need, minimization criteria, resource conflicts (e.g., cultural, LWC, riparian), reclaiming routes, etc.

2024 Schedule Highlights

- Release Preliminary Alternatives and Scoping Report to Cooperators on **February 8th**
- Release Preliminary Alternatives and Documents to the Public on **February 22, 2024**
- **Prepare Draft EA, March/April 2024**
- Formal Public Comment Period: **May 2024**


- Alt A: Baseline Alternative, this is our current travel plan.

- Alternative B has a total reduction of 215 miles
- Alternative C has a total increase of 279 miles
- Alternative D has a total increase of 678 miles

 - Comments from them will be considered as we create draft EA.


