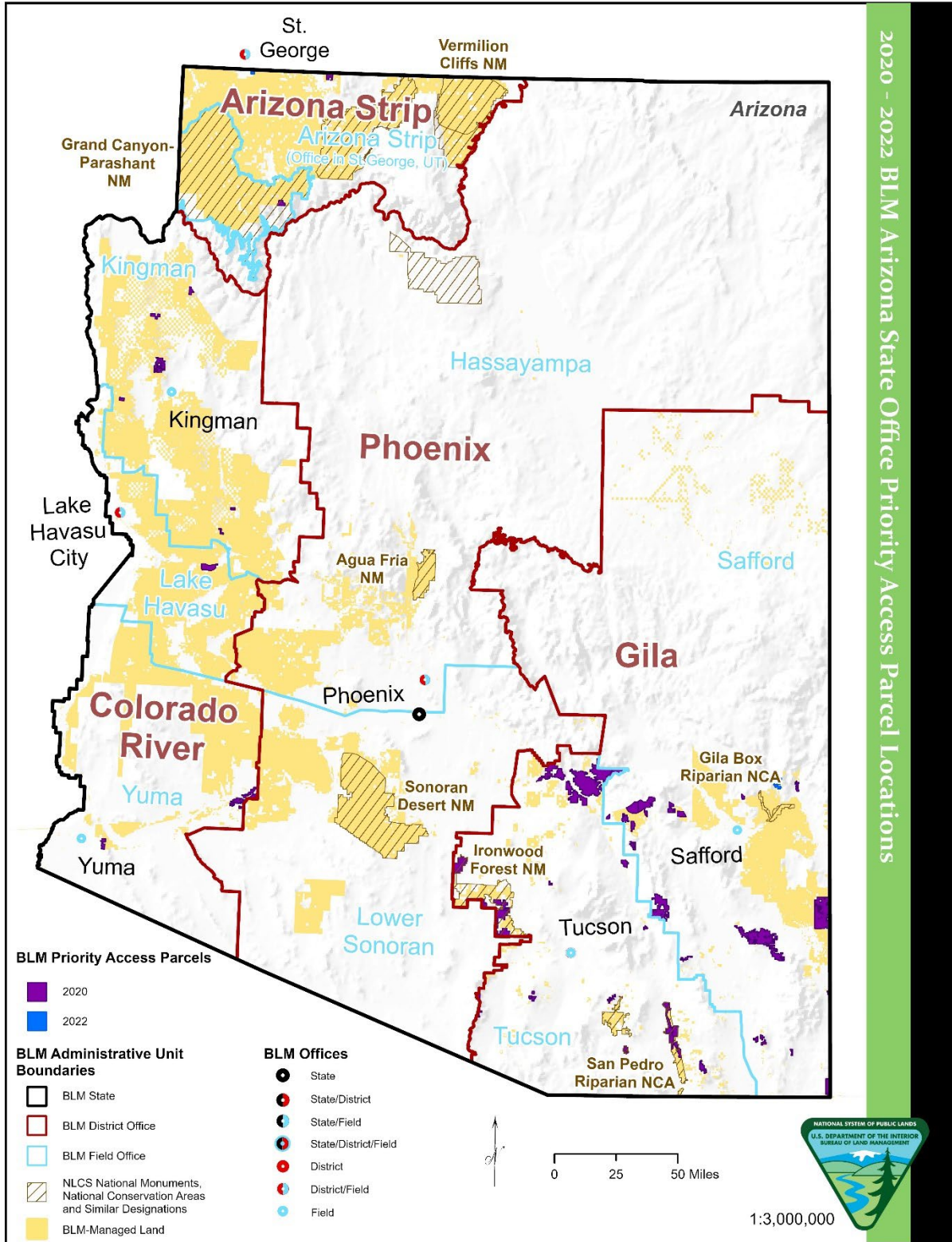

## California State Office Priority Access List Parcel Locations





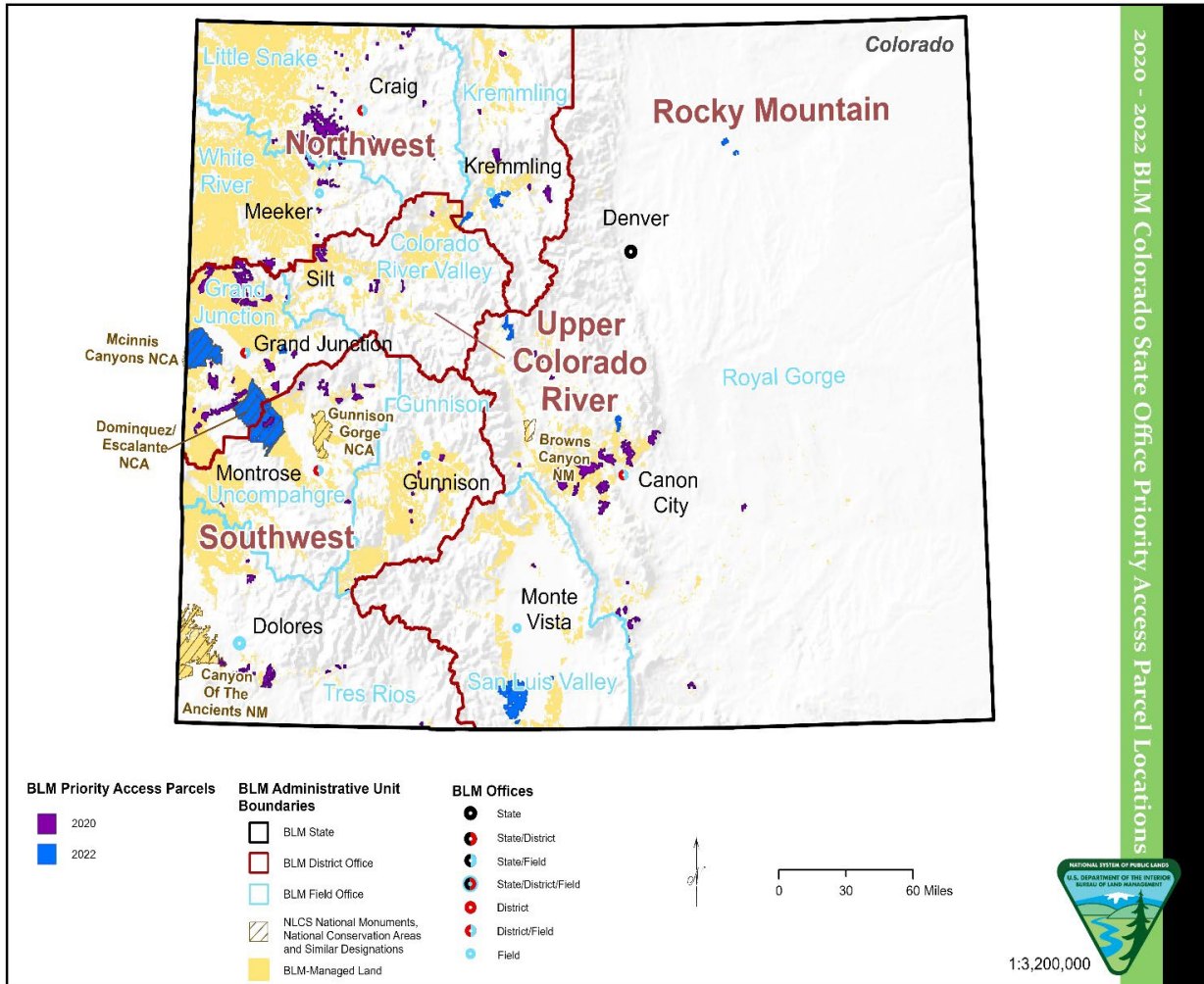

### Nevada State Office Priority Access List Parcel Locations





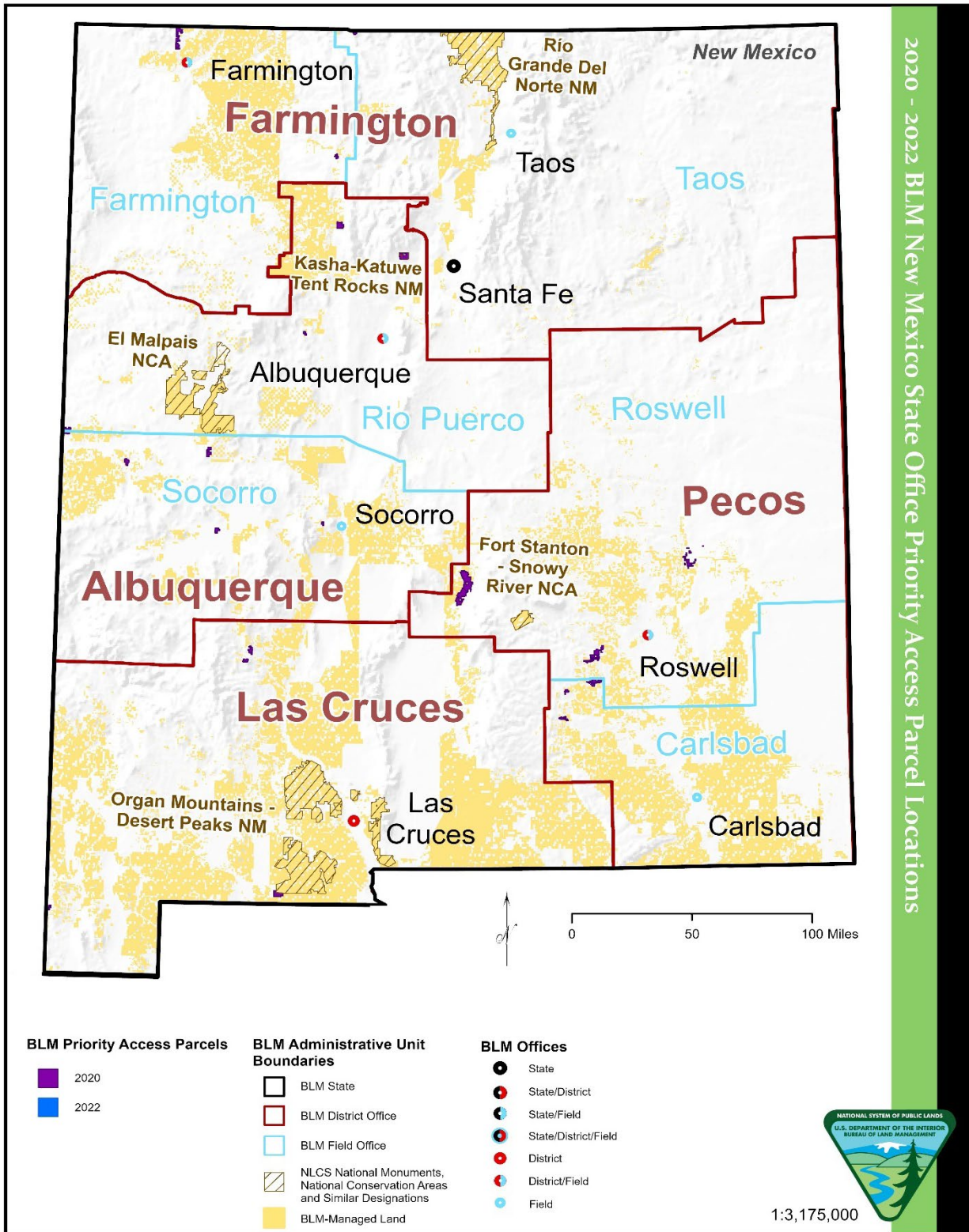

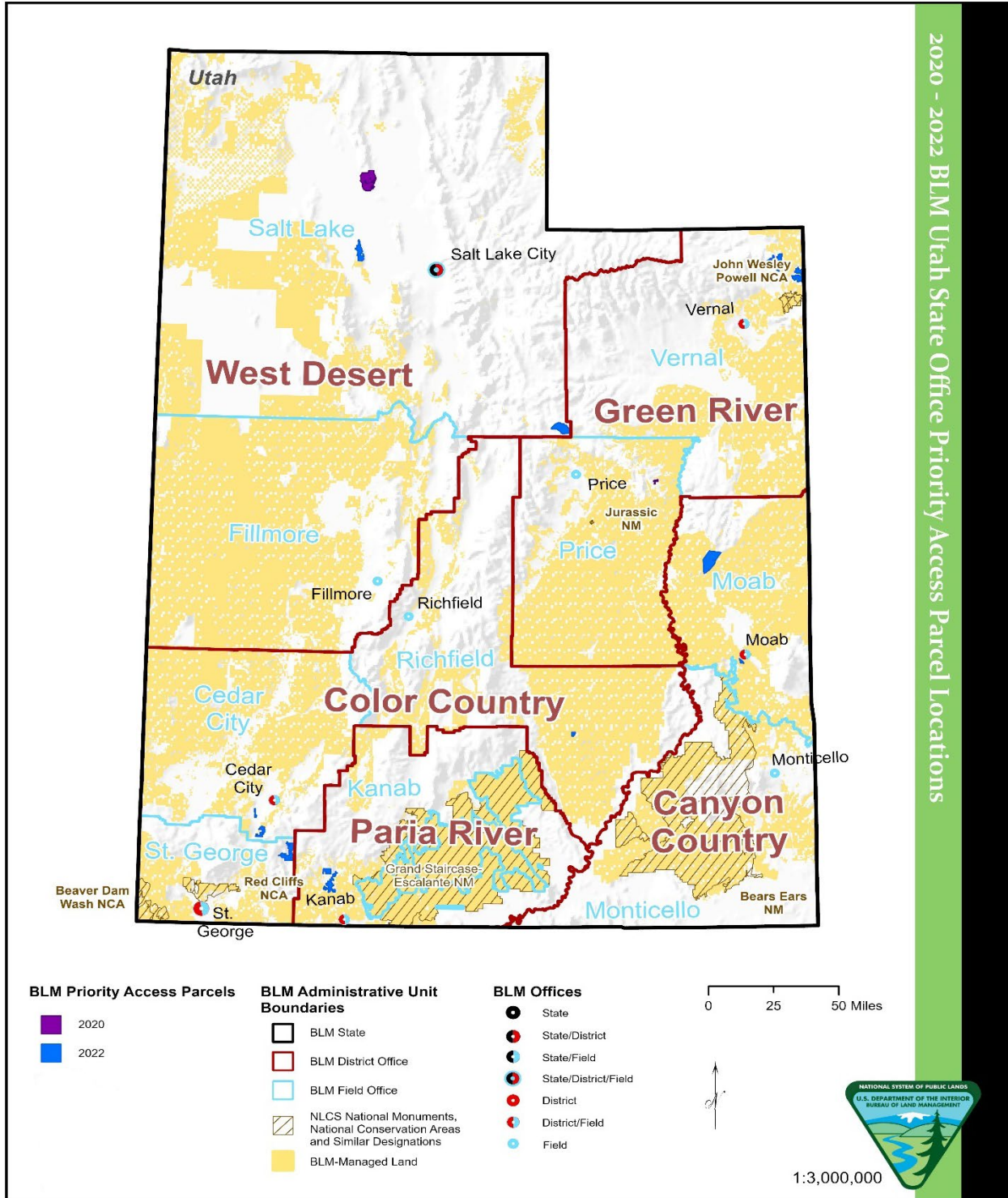

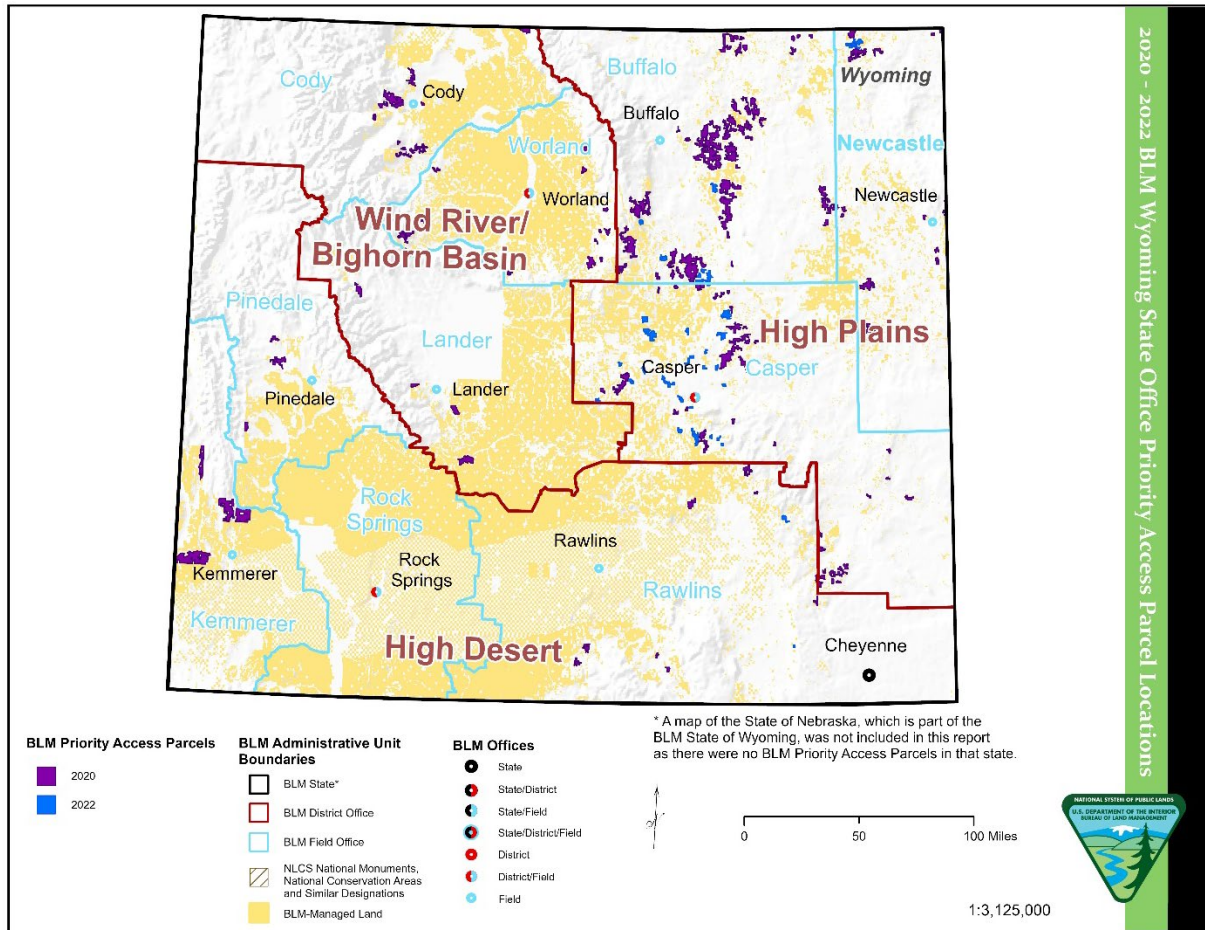
