## SITUATION

**Current Situation:** Today's operations included continued work to secure the fire line on both flanks of the fire. Crews continued fire line construction to the cliffs' edge on the south flank and handline connecting to dozer line on the west flank. Crews continue to work on containing any smaller fires that migrated off the rim. Operationally, the goal remains to keep the fire to the smallest acres/smallest footprint as possible and utilize standard firefighting techniques using existing roads, natural barriers, and equipment to safely suppress the fire.

**Evacuations: None.** Should evacuations become necessary, the Kane County Sheriff's Office will make the initial evacuation notifications through Kane County's Community Emergency Notification System on Everbridge. **Road Closures:** Area and road closures are in effect. On Skutumpah Road between Johnson Canyon Road and Lick Wash the road is open to resident traffic only.

Nephi Pasture and Crocodile parking lots, as well as Nephi Pasture Road are closed to the public as these areas will be used for fire operations only.

We strongly discourage ALL recreational activities in the Nephi Pasture Region and along Skutumpah Road.
