Amount Expended: \$500.00

Global Youth Service Day occurred on 4/26/2024 at the Lovelock Cave, Nevada. Over 30 volunteers participated in stewardship projects. These projects included the construction of a 20 foot long rock retaining wall and restoring the interpretive trail back to its original width. A user created trail was decommissioned by the younger participants in the group and the parking area was filled and graded due to water erosion. At the end of the day all volunteers participated in the Junior Ranger Pledge.



Extended turnpike

Amount Expended: \$500.00

At the Water Canyon Recreation Area, there are many side creeks, seeps, and seasonal springs. Due to the abundance of these water sources, low lying areas are prone to water damage, minor flooding, and erosion during spring and early summer. The access path to campsite # 6 is prone to seasonal flooding. Recreation Fee Program funds were used to purchase additional gravel and tools to extend the existing turnpike by 5 feet on either end, providing a dry and safe path for public access to the campsite.
