#### Amount Expended: \$43,795.46

Sitting around a campfire, gathered on a beach, or wandering down the trail, interpretive programs immerse visitors in the natural world around them. Fee funds allowed park rangers to give 15 interpretive programs at Loon Lake Campground, as well as support the purchasing of supplies and pay for the park rangers. Rangers gave programs on wildlife, geology, plants, fire, and local history. Plus, the rangers were able to induct dozens of new Junior Rangers!
