Newly Installed Alsea Falls Fee Machine and Kiosk

Amount Expended: \$12,200.00

New fee machine technology has enabled Northwest Oregon District to provide better customer service and convenience for visitors, while streamlining our fee collection process. Solar-powered options, such as the machine installed at Alsea Falls Recreation Area in 2023, have enabled park rangers to provide the convenience of paying with a card at more remote sites. In addition to being more convenient, fee machines greatly increase overall fee compliance and reduce instances of theft.

Wildwood Boardwalk Restoration

Amount Expended: \$10,100.00

In 2023 Northwest Oregon District recreation staff worked to restore a section of boardwalk at Wildwood Recreation Site in partnership with local non-profit AntFarm Youth Services. BLM park rangers and AntFarm work crews successfully replaced damaged handrail and decking on approximately 200 feet of boardwalk and restored safe access to the popular Wetlands Boardwalk Trail.
