

#### Peekaboo OHV Trailhead Expansion

Amount Expended: \$53,000.00

This project was implemented to facilitate public and commercial visitor use and enjoyment of this popular OHV area. Funding was also generated through a Fiscal Incentive Grant in coordination with Kane County and the UT/AZ ATV Club. The project expanded the parking area to accommodate increasing visitor and commercial operator use.

#### Tilted Mesa MTB Trails Development

Amount Expended: \$92,000.00

This project was implemented to address issues and needs related to user conflicts between mountain biking, equestrian, OHV and other public uses. Funding was also generated through a grant award from the Utah Outdoor Recreation Grant. The developed trail system includes approximately 12 miles of singletrack trail, expanded parking (55 parking spots), restroom and public information facilities.

#### **Planned Activities**

Development of the Tilted Mesa MTB trailhead.

Complete expansion of Peekaboo trailhead. Install toilet, road base/gravel and other infrastructure at Tilted Mesa trail system and Peekaboo OHV trailhead.

Continue to maintain existing recreation facilities at developed sites.

Perform upgrades to electronic payment platforms at fee-based sites.

Partially fund salaries to support maintenance activities at developed recreation sites.

Implement improved public information messaging and safety projects at 10 trailheads.

Work with interns to enhance visitor contact options and maintain recreation facilities.
