Amount Expended: \$3,818.00

The Casper Field Office (CFO) obligated approximately \$3,818.00 of FLREA dollars for two new Iron Rangers, at the Rim and Lodgepole campgrounds, on Muddy Mountain EEA. Muddy Mountain EEA hosts two developed campgrounds (Rim and Lodgepole) plus many miles of trails, in the Casper area. The old Iron Rangers were subject to vandalism.

Amount Expended: \$37,032.00

The Casper Field Office (CFO) manages 17 recreation sites, some of which are in remote locations. Equipment, supplies, and vehicles are highly important to maintain the quality of these areas. A total of \$37,032.42 of FLREA funds were used in CFO for the associated costs related to facilities cleaning and maintenance plus supplies, that were completed during the 2023 Fiscal Year.
