

### **Southern Nevada Public Land Management Act (SNPLMA)**

- SNPLMA Round 20 the BLM Received 49 Nominations from partners requesting \$680 million dollars.
- Completed a 45-day public comment period that resulted in 1,584 comments.
- Executive Committee made final recommendations to the Secretary on 37 projects valued at \$375 million.

### **Energy and Infrastructure**

- Dry Lake East Energy Center Environmental Assessment completed, Finding of No Significant Impact signed, and Decision Record issued.
- Dry Lake East Energy Center Right-of-Way Grant for solar generating facility issued.
- Rough Hat Clark Solar Project Draft Environmental Impact Statement (DEIS) and Resource Management Plan Amendment (RMPA) released for public comment.
- Copper Rays Solar Project DEIS/RMPA released for public comment.
- Bonanza Solar Project DEIS/RMPA released for public comment.
- 10 Solar Applications Prioritized (4 Medium, 6 Low)
- 20 Cost Recovery Agreements for project applications executed, per BLM Nevada Policy

### **Red Rock/ Sloan Field Office**

- Homeland Security and the BLM hosted a Naturalization Ceremony that welcomed 61 new U.S. citizens at Red Rock Canyon NCA.
- Finalized a contract for an ethnographic study to be conducted at both NCAs.
- BLM hosted a Winter Gathering with the LV Paiute tribe and Southern Nevada Conservancy.
- BLM hosted a Book Signing with a Native American author and Southern Nevada Conservancy.
- BLM hosted several meetings and hikes with interested tribes to collaborate on the Sloan Canyon Visitor Contact Station programs, products, and building features.
- Engaged with volunteers with “Blacks in Nature” on several clean-ups and hikes at both NCAs.
- Engaged with other countries including South Africa and Scotland for World Ranger Day.
- Complete and distributed Sloan Canyon Junior Ranger Book and distributor them to our Tribal Partners.

### **Las Vegas Field Office**

- Three Kids Mine land conveyance was completed.
- Completed 277 Lands related federal actions this year!
- The Gold Butte National Monument Historic Properties Treatment Plan was completed this year.
- The Las Vegas Field Office held a competitive mineral materials sale this year. The winning bid resulted in BLM awarding a contract for 2.5 million tons of mineral materials for \$7.6 million.

- Large Special Recreation Permitted Events this past year included the Rise Festival, Mint 400 Off Road Race, SNORE 250 Off Road Race, Rage at the River Off Road Race, and the Laughlin Desert Classic and UTV Legends Off Road Races.

### **Law Enforcement**

- Conducted 200 arrests.
- Completed 50 stolen vehicle recoveries.
- Conducted 103 drug seizures.
- Assisted with 136 Search and Rescue Operations.
- Issued 4,300 verbal or written warnings.
- Issued 500 citations.
