Notice is hereby given that the Bureau of Land Management (BLM) is considering a proposal to exchange lands with the New Mexico State Land Office as directed by the John D. Dingell, Jr. Conservation, Management and Recreation Act of 2019, Public Law 116-9, Subtitle C, Part I, Section 1201(d)(3), and pursuant to Section 206 of the Federal Land Policy and Management Act of 1976 (43 U.S.C. 1716), as amended. The exchange would consolidate land ownership for both the State of New Mexico and the United States; place State mineral interests and valuable conservation and recreation lands within Organ Mountains-Desert Peaks National Monument into Federal ownership; and place lands with revenue-producing potential located outside of special management areas into State ownership for the benefit of New Mexico's public schools and other public beneficiaries. NEPA process to help support compliance with applicable procedural requirements under the Endangered Species Act (16 U.S.C. 1536) and Section 106 of the National Historic Preservation Act (54 U.S.C. 306108) as provided in 36 CFR 800.2(d)(3), including public involvement requirements of Section 106. The information gathered from public involvement concerning historic and cultural resources and threatened and endangered species within the area potentially affected by the proposed exchange will assist the BLM in identifying and evaluating impacts to such resources.
