Becky Peak Wilderness

Legal Boundary Description

The boundary of the Becky Peak Wilderness established in the "White Pine County Conservation, Recreation, and Development Act of 2006", Public Law No. 109-432, dated December 20, 2006, Bureau of Land Management serial No. N-83920, located in Townships 23, 24, and 25 North, Range 65 East, Mount Diablo Meridian, White Pine County, in the state of Nevada, and is more particularly described as follows:

The area contained within the bounds of this description is 18,190 acres, more or less.
