Highland Ridge Wilderness

Legal Boundary Description

The boundary of the Highland Ridge Wilderness established in the "White Pine County Conservation, Recreation, and Development Act of 2006", Public Law No. 109-432, dated December 20, 2006, Bureau of Land Management serial No. N-83918, located in Township 9 1/2 North, Range 70 East, Townships 10 North, Ranges 68, 69, and 70 East, Townships 11 North, Ranges 68, 69, and 70 East, and Township 12 North, Range 68 East, Mount Diablo Meridian, White Pine County, in the state of Nevada, is more particularly described as follows:

- 1. BEGINNING at the corner of sections 18 and 19 only, on the west boundary of T. 11 N., R. 69 E.; thence easterly, a distance of approximately 4.0 miles, on the lines between sections 18 and 19, sections 17 and 20, sections 16 and 21, and sections 15 and 22, T. 11 N., R. 69 E., to the corner of sections 14, 15, 22, and 23;
- 2. thence northerly, a distance of approximately 0.55 miles, on the line between sections 14 and 15, T. 11 N., R. 69 E., at approximate latitude 38°49'35.6" North, longitude 114°12'24" West;
- 3. thence easterly, a distance of approximately 0.45 miles, to the base of right bank of a wash, course northerly, at approximate latitude 38°49'35.6" North, longitude 114°11'53" West;
- 4. thence northerly, a distance of approximately 0.75 miles, with the meanders of the base of right bank of the wash, course northerly, to a point on said base of right bank, at approximate latitude 38°50'12.5" North, longitude 114°11'42" West;
- 5. thence northeasterly, a distance of approximately 0.3 miles, to a point, at approximate latitude 38°50'25" North, longitude 114°11'33" West;
- 6. thence northerly, a distance of approximately 0.1 mile, to a point, at approximate latitude 38°50'30.5" North, longitude 114°11'32.0" West;
- 7. thence northeasterly, a distance of approximately 0.1 mile, to intersection with a line parallel with and 100 feet southeasterly of the southeasterly edge of a trailhead vehicle parking area, at approximate latitude 38°50'33.50" North, longitude 114°11'26.85" West;
- 8. thence southeasterly turning northeasterly, a distance of approximately 250 feet, on a line parallel with and 100 feet southwesterly and southeasterly of the southwesterly and southeasterly edge of the vehicle parking area to intersection with a line parallel with and 100 feet southeasterly of the southeasterly edge of an unimproved road, bears northeasterly and southwesterly, at approximate latitude 38°50'34.8" North, longitude 114°11'23.8" West;
- 9. thence northeasterly, a distance of approximately 2.0 miles, on a line parallel with and 100 feet southeasterly of the

- 10. thence easterly, a distance of approximately 0.15 miles, on the line between corners No. 4 and No. 5 of Homestead Entry Survey No. 155, T. 11 N., R. 70 E., to corner No. 4;
- 11. thence easterly, a distance of approximately 0.35 miles, on the line between corners No. 4 and No. 3 of Homestead Entry Survey No. 155, T. 11 N., R. 70 E., to corner No. 3;
- 12. thence easterly, a distance of approximately 0.45 miles, on the line between corners No. 3 and No. 2 of Homestead Entry Survey No. 155, T. 11 N., R. 70 E., to corner No. 2, identical with corner No. 5 of Homestead Entry Survey No. 184;
- 13. thence easterly, a distance of approximately 0.85 miles, on the line between corners No. 5 and No. 4 of Homestead Entry Survey No. 184, to corner No. 4;
- 14. thence easterly, a distance of approximately 0.15 miles, on the line between corners No. 4 and No. 3 of Homestead Entry Survey No. 184, T. 11 N., R. 70 E., to corner No. 3;
- 15. thence northerly, a distance of approximately 30 feet, on the line between corners No. 3 and No. 2 of Homestead Entry Survey No. 184, T. 11 N., R. 70 E., to intersection with a line parallel with and 100 feet southerly of the southerly edge of an unimproved road, bears easterly and westerly, at approximate latitude 38°51'27" North, longitude 114°07'32" West;
- 16. thence easterly, a distance of approximately 0.4 miles, on a line parallel with and 100 feet southerly of the southerly edge of the unimproved road to a stainless steel post, 28 inches long, 2 1/2 inches diameter, set 24 inches in the ground over a plastic-encased magnet, with brass cap marked HRW N83918 2013 and a line indicating the direction of the boundary, at intersection with a line parallel with and 100 feet easterly of the easterly edge of a jeep trail, bears northerly and southerly, at observed latitude 38°51'24.487" North, longitude 114°07'04.403" West;

- 19. thence southwesterly, a distance of approximately 0.55 miles, to a spur, slopes easterly, at approximate latitude 38°50'03" North, longitude 114°07'51" West;
- 20. thence southerly, a distance of approximately 0.85 miles, to the base of left bank of wash, course southeasterly, at approximate latitude 38°49'18" North, longitude 114°08'06" West;
- 21. thence northwesterly, a distance of approximately 0.45 miles, with the meanders of the base of the left bank of wash, course southeasterly, to a point on said base of left bank, at approximate latitude 38°49'28" North, longitude 114°08'32.5" West;

- 23. thence southeasterly, a distance of approximately 0.6 miles, to intersection with a line parallel with and 100 feet northwesterly of the northwesterly edge of an unimproved road, bears northeasterly and southwesterly, to a stainless steel post, 28 inches long, 2 1/2 inches diameter, set 24 inches in the ground over a plastic-encased magnet, with brass cap marked HRW N83918 2013 and a line indicating the direction of the boundary, at observed latitude 38°48'19.492" North, longitude 114°08'44.347" West;
