Includes NEPA, valuation report, Section 7 consultation, Section 106 compliance, and other clearances for processing use authorizations as appropriate, and all associated case recordation and data entry, with the following exceptions.

Includes the cost of land use planning amendments and commercial activity plans prepared solely for a community pit or common use area designation or for an individual disposal within these areas. Multidisciplinary planning costs are no longer coded to this program element or to functional area 1330. Costs for multidisciplinary land use plans are charged to functional area 1610.

Mineral materials free use permits and permits for exploration, sampling and testing are no longer coded to this program element. All costs for mineral materials permits should be charged to program element FW.

Law enforcement duties are no longer coded to this program element. All costs of law enforcement should be charged to one of the following program elements: NU, NV, NY, NZ, and OA.
